The meeting was suspended at 4.10 p.m. on Thursday, 19 December and resumed at 4.05 p.m. on Tuesday, 24 December.

Members are reminded that pursuant to decisions taken upon consideration of other reports of the Main Committees, statements will be limited to explanations of vote. I would like to remind members that, in accordance with decision 34/401, a delegation should, as far as possible, explain its vote only once, that is, either in the Committee or in plenary meeting, unless that delegation's vote in plenary meeting is different from its vote in the Committee, and that explanations of vote are limited to 10 minutes and should be made by delegations from their seats. When there are multiple proposals under an agenda item, statements in explanation of vote before the voting on any or all of them should be made in one intervention, followed by action on all of them, one by one. Thereafter, there will be an opportunity for statements in explanation of vote after the voting on any or all of them in one intervention.


I would like to advise representatives that we will proceed to take decisions on Committee recommendations in the same manner as was done in the Committee concerned, unless the Secretariat is notified otherwise in advance. This means that where separate or recorded votes were taken, we will do the same. I also hope that we may proceed to adopt without a vote those recommendations that were adopted without a vote in the Committee concerned. 

Draft resolution (A/79/L.21)

The President: Members will recall that, in its decision 79/537, of 6 December 2024, the Assembly decided, on an exceptional basis, to convene a meeting of the Assembly in December 2024 to consider the draft new Programme of Action for Landlocked Developing Countries for the Decade 2024-2034 and that the meeting would hear statements by the President of the General Assembly, the Chair of the Group of Landlocked Developing Countries and the Secretary-General of the Third United Nations Conference on Landlocked Developing Countries to be followed by the adoption of the draft Programme of Action.

In that connection, as announced at the 54h plenary meeting, on 19 December 2024, the President received a request from the sponsor of the decision to postpone the said meeting to January 2025. In order for the Assembly to take up this proposal and proceed to take action on draft resolution A/79/L.21 at this time, it must first agree, under rule 81 of its rules of procedure, to reconsider the provision contained in paragraph (b) of decision 79/537.

May I take it that the Assembly wishes to reconsider the provision contained in paragraph (b) of decision 79/537?

I now give the floor to the representative of the Russian Federation.

Mr. Leonidchenko (Russian Federation) (*spoke in Russian*): The Russian Federation, as the initiator of the process to develop the first international treaty in history on information security, believes that the General Assembly should unanimously adopt the draft convention against cybercrime. This document is the outcome of five years of painstaking work on the part of United Nations Member States since the adoption, in 2019, of resolution 74/247, established the ad hoc committee, and until the adoption of the draft of this treaty in August 2024.

Negotiations were tense, and not all participants engaged in a constructive spirit. Certain countries openly tried to undermine the process and used dubious methods to do so. They exerted political pressure and used certain tamed non-governmental organizations and companies to that end. They even hindered the participation of the Russian delegation activities of the ad hoc committee. In particular, Austria and the United States refused to issue visas to heads of delegation, deputy heads and experts, thereby violating their obligations as host countries of the United Nations Headquarters and its offices.

Together with certain other delegations, they called for expanded participation of non-State actors in the work of the ad hoc committee, thus undermining the intergovernmental negotiation process in the United Nations. The bad sportsmanship of those States was also shown in the discussions of the ad hoc committee. Despite adopted resolution 74/247, the mandate of this United Nations body, namely, to develop a comprehensive specialized international treaty, Western countries actively promoted their own interpretation of the human rights agenda within it, ignoring the aspirations and motivations of developing countries. The efforts of the delegations of the United States and its allies caused the text to exclude a number of provisions

on the use of information and communication technologies (ICTs) for terrorist and extremist purposes and how to prevent such use, as well as on the illegal circulation of narcotics and weapons, and incitement to suicide and other dangerous forms of crimes, including attacks on critical ICT infrastructure. Modern methods of identification of ICT crimes, such as special investigation methods, were also not taken into account.

Furthermore, there are provisions left in the text that could be used by interested States to withdraw from cooperation in combating ICT criminals. In that regard, the mandate of the ad hoc committee, in accordance with resolution 72/247, was only partially implemented.

Russia adopted the August draft convention, with reservations, and reserved the right to make statement and to issue relevant reservations when signing and ratifying the convention. Despite the shortcomings of the text, the adopted treaty is a strong foundation for law enforcement cooperation to combat ICT crime. It is focused on fighting unsanctioned access to electronic data and their illegal seizure, as well as forgery, embezzlement, fraud. It also combats the laundering of ill-gotten revenue, as well as the exploitation and harassment of children.

The document also allows for carrying out the main principle of the United Nations — protecting sovereignty — and facilitates the exchange of electronic evidence and the operation of a network of national contact centres for investigating crime around the clock. It establishes a permanent review body, that is a conference of State parties.

However, this universal treaty should not stand still. It needs to further evolve and improve. That can be done through the elaboration of additional protocols. There are opportunities to criminalize the use of ICTs for terrorist and extremist purposes.

I would also like to thank the Socialist Republic of Viet Nam for the initiative of organizing a ceremonial signing of the convention against cybercrime in Hanoi. We are prepared to provide partners with support in that event and hope to attract the largest possible number of participants. We encourage the United Nations Office on Drugs and Crime to implement the necessary assistance, including through Russian voluntary contributions to the budget of that body. We call on United Nations Member States to go to Viet Nam to sign this international treaty and ratify it immediately. We believe that the launch of mechanisms provided for by the convention will allow us to significantly combat information crime, which is growing exponentially.

The President: We will now take a decision on the draft resolution. The Committee adopted it without a vote. May I take it that the Assembly wishes to do likewise?

The draft resolution contained in A/79/460 was adopted (resolution 79/243).

The President: Before giving the floor to speakers in explanation of vote after the voting, may I remind delegations that explanations of vote are limited to 10 minutes and should be made by delegations from their seats.

Mr. Tropepi (Argentina) (spoke in Spanish): Argentina welcomes the conclusion of the negotiations on the United Nations Convention against Cybercrime, as it enables international legal cooperation to continue and punish that scourge, which is international in scope. My country therefore joins consensus on this issue and would like to express its national position with regard to the tenth preambular paragraph; article 14, paragraph 4; article 15, paragraph 4; and article 16, paragraph 5, which are concerning because they could enable the exploitation of minors. Sexual abuse of children through generative artificial intelligence or through other means is an intolerable affront to human dignity. In my delegation's view, there should be no

concessions or loopholes that enable the exploitation of minors, nor should impunity for cybercrime be justified.

Article 14, paragraph 4, could normalize child exploitation. Even if images are created by artificial intelligence, the creation of such material could contribute to facilitating child exploitation and abuse. It is a bridge to illegal material, serving as an incentive for consumers and feeding the demand for child pornography. It could also adversely impact and facilitate grooming.

Article 15, paragraph 4, enables the same scenario, promoting the exploitation of children and teens through parents, guardians or third parties that could induce the performance of acts prohibited for adults, but acts that could go unpunished if carried out by minors. Argentina is compelled to protect children and teens from the exploitation enabled by this regulation.

Article 16, paragraph 5 requires proof of the intention to cause harm, adding requirements for the classification of this crime, which does so much harm to children and teens. The objective action of non-consensual dissemination should suffice to meet the criteria for this crime. Any evidentiary difficulty could hinder or make it impossible to meet the burden of proof, which should be lowered for the benefit of the victims.

Argentina's understanding of gender in the sense established by article 7, paragraph 3, of the Rome Statute. My delegation wishes to add that choosing the perspective of gender over other vulnerabilities deprioritizes the other vulnerabilities and is exclusive, rather than inclusive. Argentina dissociates itself from the above-mentioned articles and intends to formulate its reservations to the treaty in an opportune manner with regard to non-negotiable points, in the light of the obligations undertaken upon accession to the Convention on the Rights of the Child and the Optional Protocol to the Convention on the Rights of the Child on the sale of children, child prostitution and child pornography.

Mr. Tran Nam Trung Dang (Viet Nam): My delegation welcomes the adoption by consensus of the United Nations Convention against Cybercrime. The Convention is the first international legal instrument that governs cyberspace. It also exemplifies the United Nations multilateral approach to tackling common global challenges. It bridges divides by fostering collaboration between nations with different technological capacities. It is a collective accomplishment by all Member States, regardless of size, level of development or geographic region.

I am deeply honoured and humbled by the support and trust of Member States in selecting my capital city of Hanoi to be the venue for the signing ceremony in 2025. These decisions reflect their confidence in Viet Nam's unwavering commitment to multilateralism and its capacity to meaningfully contribute to addressing cybercrime. Viet Nam will spare no effort to ensure the success of this significant event. We look forward to welcoming the delegations of all Member States to Hanoi next year.

I wish to thank all the delegations for their cooperation and to assure them that changes made during the 22nd resumed formal meeting of the Fifth Committee will be reflected in the draft resolutions, decisions and reports, which will be issued in all official languages.

Before I conclude, allow me, on a personal note, to thank the Chair of the Fifth Committee, Ambassador Egriselda González López, and her team — Ms. America Herrera Garcia and Ms. Sofia Amaya Garay — for the dedicated way in which they guided us through our difficult work and to thank my colleagues in the Bureau — Ms. Johanna Bischof, Mr. Szymon Pekala and Mr. Surat Suwannikkha. Working with them is always a truly gratifying experience.

My delegation remains deeply concerned about the findings of independent review groups, which indicate that the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) faces challenges due to increased politicization among its staff, affecting its neutrality. The report also States that

UNRWA facilities have been misused for political or military gains, undermining its neutrality.

My delegation is deeply disturbed by the findings of the Office of Internal Oversight Services, which indicated, in nine cases, that UNRWA staff members may have been involved in the armed attacks of 7 October 2023.

Therefore, Israel has put forward these oral amendments. We ask colleagues to vote in favour of them to send a message that the Agency must be held accountable, as it has violated its principles of neutrality.

The President: I now give the floor to the representative of Cuba to introduce an oral amendment.

Mr. Tur de la Concepción (Cuba) (*spoke in Spanish*): The Cuban delegation wishes to introduce oral amendments to the proposed programme budget for 2025, specifically with regard to the section devoted to the Special Envoys of the Secretary-General.

The Cuban delegation wishes to introduce the following oral amendments:

"Requests the Secretary-General to issue a corrigendum to his report A/79/6 (Sect.3/Add.2".

(spoke in Spanish)

We are introducing this we wished to address the absence of a clear mandate on the work of these Special Advisers. We think, therefore, that the best way to proceed is as we have set out in the proposed oral amendments.

We reiterate that the entire process of the submission of resolution 78/282 was highly politicized. There had been no consultation in the country to which the resolution relates, and individuals submitted the resolution without the consent of the presidency of their own State. Moreover, no discussion had taken place either among the peoples living in Bosnia and Herzegovina or in the region at large. On the contrary, a pall of secrecy had been cast over the preparation of the resolution.

It all resulted in United Nations Member States with having to vote on a very sensitive issue that requires consensus. All resolutions related to atrocity crimes have been adopted in the General Assembly by consensus. Moreover, more than half of the United Nations Member States did not vote for it.

We trust and believe that the financial crisis and challenges that define the environment in United Nations functions should compel us to direct financial resources from the United Nations budget, first and foremost, to field work to provide assistance to communities in conflict and post-conflict situations, with the aim of

achieving substantive reconciliation and building confidence. This resolution, and the allocation of resources for its implementation, does not serve that goal.

Mr. Evseenko (Belarus) (spoke in Russian): For the reasons stated during the Fifth Committee meetings, the Republic of Belarus disassociates itself from decisions regarding financing the International, Impartial and Independent Mechanism to Assist in the Investigation and Prosecution of Persons Responsible for the Most Serious Crimes under International Law Committed in the Syrian Arab Republic since March 2011, as well as country-specific resolutions of the Human Rights Council, the concept of the responsibility to protect, and the financing of resolution 78/282, on the "International Day of Reflection and Commemoration of the 1995 Genocide in Srebrenica".
